### Health Policy Research Fellowship

**Deadline:** October 21, 2009

Award Amount: \$89,000 per year

The Robert Wood Johnson(RWJ) Foundation Scholars in Health Policy Research program helps to develop a new generation of creative health policy thinkers and researchers within the disciplines of economics, political science and sociology. Each year the program selects up to nine highly qualified individuals for two-year fellowships at one of three nationally prominent universities with the expectation that they will make important research contributions to future health policy in the United States. Recent graduates of doctoral programs in economics, political science and sociology, including junior faculty, to apply. We will give preference to applicants who have not previously worked extensively in health or health policy research.

#### Eligibility:

- Applicants must have received a doctoral degree after January 1, 2005, but no later than July 2010. For those expecting to receive degrees in 2010, all degree requirements must be completed by July 15, 2010.
- All applicants must be citizens of the United States or its territories or have permanent residency status at the time of application.
- The RWJ Foundation embraces racial, ethnic and gender diversity, and encourage applications from candidates who come from groups that historically have been underrepresented in the three disciplines.

The following criteria will be considered in the course of the application review process:

- The applicant's potential to contribute creatively as a social scientist to future U.S. health policy thinking—either by identifying emerging health policy issues and problems or by bringing new insight to the examination and analysis of existing issues and problems.
- The applicant's commitment to a career consistent with the program's purpose and goals.
- The quality of the applicant's past research, including dissertation research.
- The capability of the applicant to undertake this challenging program.
- Recommendations by faculty and other individuals with whom the applicant has studied or worked.

### Graduate Environmental Study Fellowship

Award Amount: \$37,000

The U.S. Environmental Protection Agency (EPA), as part of its Science to Achieve Results (STAR) program, is offering Graduate Fellowships for master's and doctoral level students in environmental fields of study. This Request for Application (RFA) solicits applications from students to perform graduate level investigation towards protecting human health and the environment. Applications are welcomed from students studying any academic discipline to the extent that the particular topic of research is related to EPA's mission. This includes students studying in ecology, economics, engineering, modeling, the health sciences, physical sciences, earth sciences, exposure sciences, social sciences, informational sciences, mathematical and computer sciences, and environmental sciences. Proposals may come from students in traditional and interdisciplinary academic disciplines; from students studying in emerging fields; from students utilizing multidisciplinary approaches and/or addressing multiple media; and, in areas which focus on environmental justice, environmental education, community-based participation, and/or environmental decision-making. The planned course of study and/or project must focus on one of the following topics of environmental significance: Global Change, Clean Air, Drinking Water, Water Quality: Hydrogeology and Surface Water, Water Quality: Coastal and Estuarine Processes, Human Health: Public Health Sciences, Human Health: Risk Assessment and Decision Making, Ecosystem Services: Aquatic Systems Ecology, Ecosystem Services: Terrestrial Systems Soil and Plant Ecology, Ecosystem Services: Terrestrial Systems Animal Ecology Pesticides and Toxic Substances, Land Protection, Science, Technology For Sustainability: Green Engineering/Building/Chemistry/Materials, Science & Technology for Sustainability: Energy Science & Technology for Sustainability, Environmental Behavior & Decision Making, Emerging Environmental Approaches: Informatics.

Award Amount: \$2,000 royalty payment. When the exhibition tour is completed, photographers will receive the framed and matted work. The Open Society Institute (OSI) will cover the costs of returning work up to \$750 for photographers based in the United States and \$1,250 internationally.

The Open Society Institute invites photographers to submit a body of work for consideration in the Moving Walls 17 group exhibition. Moving Walls recognizes the brave and difficult work that photographers undertake globally in their documentation of complex social and political issues. Their images provide the world with human rights evidence, put faces onto a conflict, document the struggles and defiance of marginalized people, reframe how issues are discussed publicly, and provide opportunities for reflection and discussion. Through Moving Walls, OSI honors this work while visually highlighting the mission of our foundation to staff and visitors. Any emerging or veteran photographer who has completed a body of work on a human rights or social justice issue may apply for Moving Walls. Work in progress

may be submitted as long as a substantial portion of the work has been completed. We will accept any genre of photography that is documentary in nature and is not staged or manipulated. In addition, priority will be given to work that addresses issues and geographic regions of concern to OSI.

New American Fellowship

Award Amount: \$20,000 and tuition up to \$16,000 per academic year

The Paul & Daisy Soros Fellowships for New Americans is to provide opportunities for continuing generations of able and accomplished New Americans to achieve leadership in their chosen fields. The Program is established in recognition of the contributions New Americans have made to American life and in gratitude for the opportunities the United States has afforded the donors and their family. A *New American* is an individual who (1) is a resident alien, i.e., holds a Green Card; or, (2) has been naturalized as a US citizen, or (3) is the child of two parents who are both naturalized citizens. The Program is open to individuals who retain loyalty and a sense of commitment to their country of origin as well as to the United States, but is intended to support individuals who will continue to regard the United States as their principal residence and focus of national identity. The applicant must either have a bachelor's degree or be in her/his final year of undergraduate study. Those who have a bachelor's degree may already be pursuing graduate study and may receive Fellowship support to continue that study. Individuals who are in the third, or subsequent, year of study in the same graduate program are not, however, eligible for this competition. Students who have received a master's degree in a program and are continuing for a doctoral degree in the same program are considered to have been in the same program from the time they began their work on their master's degree. To be eligible you must not be older than thirty years of age as of November 1, 2009.

The J. Paul Getty Trust's Library research grants are intended for scholars of all nationalities and at any level who demonstrate a compelling need to use materials housed in the Research Library, and whose place of residence is more than eighty miles from the Getty Center. Projects must relate to specific items in the library collection. The Research Library at the Getty Research Institute focuses on the history of art, architecture, and archaeology with relevant materials in the humanities and social sciences. The range of the collections begins with prehistory and extends to contemporary art. Presently, the collections are strongest in the history of western European art and culture in Europe and North America; however, in recent years, they have expanded to include other areas, such as Latin America, Eastern Europe, and selected regions of Asia.

Garden and Landscape Fellowships

**Deadline:** November 1, 2009

Award Amount: \$27,000-\$47,000

The Dumbarton Oaks Research Library and Collection, in Washington, DC, an institute of Harvard University, supports Garden and Landscape Fellowships. The program seeks a balance between historical research and investigations of current practice, between inquiries at the scale of the garden and those addressing larger landscapes. The program invites consideration of all aspects of this interdisciplinary and international field: agricultural, architectural, art historical, botanical, cultural, ecological, economic, geographical, horticultural, social, and technological. Applicants are encouraged to consider topics from a variety of perspectives, including design, patronage, iconography, ideology, reception, preservation, landscape performance, and user experience; and using methods from other relevant fields of the humanities (art history and criticism, literary studies, philosophy) and of the social sciences (social history, cultural geography, cultural studies, social anthropology). Complementing a traditional focus on garden history, the program invites research into the impact of current environmental conditions-accelerated global urbanization and climate change, for example-on contemporary design. Whatever their topics or methods, however, all research proposals will be considered and evaluated on their own merits. Applicants may want to consider the suitability of their proposals to the resources available at Dumbarton Oaks and in Washington. The Garden Library Rare Book Collection is especially rich in American and European materials on architecture, botany, horticulture and all aspects of garden design, as well as in selected Chinese and Japanese texts; holdings include books, but also drawings, manuscripts and prints. The reference collection has a wider scope, collecting material on garden and landscape architecture throughout the world, together with some works in social history, anthropology, geography, and iconography, including a fast-growing collection of Asian publications relevant to recent research conducted at Dumbarton Oaks. ## Post Doctorate Fellowships in Anthropology

Postdoctoral Fellowships support the writing-up of already completed research. The fellowship is awarded to scholars in the earlier stages of their careers, when they frequently lack the time and resources to develop their research for publication. Scholars with a Ph.D. in hand for no more than ten years (from the application deadline) are eligible to apply. A maximum of eight Hunt Postdoctoral Fellowships are awarded annually.

By providing funds for scholars to devote themselves full-time to writing, the Foundation aims to enable a new generation of scholars to publish significant works that will impact the development of anthropology. The program contributes to the Foundation's overall mission to support basic research in anthropology and to ensure that the discipline continues to be a source of vibrant and significant work that furthers our understanding of humanity's cultural and biological origins, development, and variation. The Foundation supports research that demonstrates a clear link to anthropological theory and debates, and promises to make a solid contribution to advancing these ideas. There is no preference for any methodology, research location, or subfield. The Foundation particularly welcomes proposals that employ a comparative perspective, can generate innovative approaches or ideas, and/or integrate two or more subfields.

The Doctoral Student Research Award promotes research that contributes to a better knowledge and understanding of Canada, its relationship with the United States, and its international affairs. Doctoral students will be provided with an opportunity to conduct part of their research in Canada. Projects that have policy relevance for Canada and Canada-U. S. relations are highly desired. The topics that are highly relevant to Canada- U. S. relations include smart and secure borders; North American economic competitiveness; regulatory cooperation; Canada-U. International Dissertation Research Fellowship for Humanities and Social Sciences (Includes Non-US Nationals)

**Deadline:** November 3, 2009

Award Amount: \$30,000

The Social Science Research Council's International Dissertation Research Fellowship (IDRF) offers nine to 12 months of support to graduate students in the humanities and social sciences who are enrolled in doctoral programs in the United States and conducting dissertation research outside of the United States. IDRF promotes research that is situated in a specific discipline and geographical region but is also informed by interdisciplinary and cross-regional perspectives. Research topics may address all periods in history, but applicants should be alert to the broader implications of their research as it relates to contemporary issues and debates. The fellowship includes participation in an interdisciplinary workshop upon the completion of IDRF-funded research. Award Amount: Fellowships range from one to three months, with stipends of \$3,000 per month. Also available are \$1,200 to \$1,700 travel stipends and dissertation fellowships with a \$1,500 stipend.

The Harry Ransom Center, a humanities research library and museum at the University of Texas at Austin, is accepting applications for its 2010-2011 Research Fellowships in the Humanities. The Ransom Center awards about fifty fellowships annually to support scholarly research projects in all areas of the humanities, including literature, photography, film, art, the performing arts, music, and cultural history. Applicants must demonstrate the need for substantial on-site use of the center's collections of art, books and periodicals, film, French and Italian, manuscripts, performing arts and

photography. Please see below for more information on each of these collections. All applicants, with the exception of those applying for dissertation fellowships, must be post-doctorates or independent scholars with a substantial record of scholarly achievement.

\*Descriptions of the Collections:

**Art:** The art collection is the Ransom Center's repository of drawings, paintings, sculpture, and limited edition prints. It includes over 65,000 American, European, and Asian works of art from the fifteenth through the twentieth centuries. Its strengths include notable American, British, French, and Mexican artists' works on paper. Complementing the Ransom Center's extensive rare book and manuscript collections are exceptional examples of literary portraiture as well as art created by writers and poets. With materials ranging from caricatures and cartoons, book illustration and fine presses, to early European popular imagery, Pre-Raphaelite art, modern French art, posters, and artists' books, the art collection holds numerous opportunities for original research and specialized study.

**Books and Periodicals:** The more than eight hundred thousand volumes gathered at the Ransom Center make possible a study of the history of the book from its beginnings in the manuscript period through the twentieth century. Among the several hundred items in the pre-1700 manuscripts collection are Ptolemaic papyri of the third to first century B.C., an eleventh-century Bede codex from the monastery at Tegernsee, the richly illuminated Chronicles (ca. 1450) of Jean Froissart (1337-1404) and the fifteenth-century Belleville Book of Hours. Incunabular holdings (three hundred eighty volumes and four hundred leaves) begin with the Gutenberg Bible of 1455. The Center's copy, on paper, is one of only five complete exemplars in the United States. The Center's Pforzheimer Library holds William Caxton's edition of Lefevre's *Historyes of Troye* (1474), the first book printed in English, along with six other works by Caxton.

**Film:** The Ransom Center film collection provides research opportunities for scholars working in history, music, popular culture, textual criticism, and film history and criticism. The collections include more than 10,000 scripts for film, television, and radio; more than 15,000 posters, lobby cards, and other advertising materials; and over a million photographs, including film stills, portrait and publicity photographs, set and location reference stills, makeup and wardrobe stills, and candid, behind-the-scenes photographs. Virtually all of the collections include correspondence, memos, production records, or business records. The bulk of the collection concerns mainstream Hollywood filmmaking from the silent era through the present day. Hollywood's Golden Age (1930-1950) is particularly well represented. Other archives relate to the Texas film industry, television, and radio.

**French and Italian:** The Ransom Center's collections of French and Italian printed and manuscript materials provide a wealth of resources for research in literature, art, and music from the medieval period through the twentieth century. The materials span the breadth of the Center's holdings; they include manuscripts, correspondence, music scores, books, drawings, paintings, prints, and photographs. The Carlton Lake collection of French literature, music, and art is particularly rich in nineteenth- and twentieth-century works and is considered to be one of the most significant resources for the study of French modernism outside France. Manuscripts: Manuscripts, annotated typescripts, corrected proofs and galleys, notes, correspondence, diaries, and volumes from the personal libraries of many of the most important twentieth-century authors of North America, Great Britain, and France are the Ransom Center's special strength. In addition, printed volumes in first and subsequent editions, as well as variants, translations, abridgements, adaptations, and bibliographical, biographical, and critical works provide a basis for the study of most of the Center's original materials.

Performing Arts: This research collection documents the history of theater, dance, costume and scenic design, opera, and popular entertainments such as vaudeville, the circus, pantomime, magic, puppetry, and minstrel shows. The primary emphasis is on British and American theater from the eighteenth through mid-twentieth centuries. In addition to playscripts, promptbooks, correspondence, playbills and programs, and clippings, the collection is rich in visual material such as production photographs, set and costume renderings, posters, prints and engravings, and set models. The archival collections are complemented by audiovisual holdings, a growing costume collection, and a comprehensive library of published materials

**Photography:** The cornerstone of the photography collection is the renowned Helmut and Alison Gernsheim collection, which is best known for its treasures of nineteenth-century photography, including the world's first photograph, a unique image created in 1826 by the French inventor Joseph Nicéphore Niépce. Since that landmark acquisition, the photography collection has expanded into such diverse areas as fine art, photojournalism, documentary photography, the history of photography, and its technology. These holdings currently amount to over five million prints and negatives, supplemented by books, manuscripts, journals, and memorabilia of significant photographers since the medium's invention.
